  - iv. Any revocation of this authority by me/us will not take effect until 48 hours after written notice of the revocation is received by the Bank from me/us;
  - v. The Bank may vary the terms and conditions under which it supplies information pursuant to this authority by written notice to me/us;
  - vi. The liability (if any) of the Bank and Xero Limited arising out of this authority is several and that neither party is jointly liable for the actions, omissions, fraud, or negligence of each other; and
  - vii. Xero Limited and the Bank's liability for the breach of any warranty implied by the Consumer Guarantees Act (if information is supplied for the purposes of a business, the Consumer Guarantees Act will not apply) or any relevant legislation in supplying the information will be, to the extent permitted by law, limited to supplying the services again; or the payment of the cost of having the services supplied again, the choice to be at the option of the Bank or Xero Limited as applicable.
